Greetings to all Ct. Patrollers with a Primary (vs. secondary) registration.

Please be advised that the Election Committee is accepting the above nominations from and for any Ct. Region Patroller (excluding Alumni, Medical Associates, Candidates and Professional Division members) for the above positions. The qualification requirements according to the Eastern Division by-laws are outlined as follows:

Region Director and Alternate Region Director candidates must be active registered Patrollers in the Region that they seek to represent, have a minimum of five seasons of Patrolling experience and achieved Senior Alpine, Senior Nordic or Certified status. Members currently registered as Auxiliary Patrollers are also qualified if they have met these requirements at some point in their Patrol career. The two year term of both positions shall commence on April 1, after the election at our Fall OEC Refresher.

It is the primary duty of the Region Director to manage the affairs of the Ct. Region with the assistance of his/her staff. However, the Region Director is also expected to be chairperson of an Eastern Division Committee, such as Finance, OEC, etc. and be a member of the Eastern Division Board of Directors. It is the duty of the Alternate Region Director to assist the Region Director as necessary and to fulfill the Region Director position should the Region Director become absent due to death, resignation or disability, until the Region Director is able to resume the position or until an election is held at the next Refresher cycle. The Alternate Region Director may, but need not, attend all meetings of the Eastern Division Board and may have the privilege of the floor if recognized by the Chair and shall have the right to vote and perform other duties and responsibilities as a member of the Eastern Division Board when acting in the stead of the Ct. Region Director or when carrying a proxy vote from a Region Delegate.
